The event, attended by 350 women litigators, took place November 5-7, 2014 at the Palmer House Hilton in Chicago, Illinois.

Refo served as a panelist amongst other ligation partners and the Honorable Nancy Friedman Atlas, Senior U.S. District Judge of the U.S. District Court for the Southern District of Texas. Their topic, "How Are We Doing? Women at Trial as Lead Counsel: How, Why, and When We Can Make It Work," touched upon how women have made great strides in litigation and more and more women seek first chair opportunities. They presented new ABA research about roles played by men and women in the courtroom, and discussed how women can advance in firms and in the eyes of clients for selection as lead counsel on major matters.

Hafen presented during a roundtable discussion entitled, "Law Firm Models: Improving Gender Equity and Performance." The session visited the notion that something is amiss with the culture of law firms when those identified in research as the "best" have equity tiers with only 15 to 20 percent women. It covered how it is time to think about diversity and inclusion as an integral piece in improving a law firm's culture, organizational stability, client loyalty and revenue generation.
