At age 30, Lang became chairman of the New Pathways for Youth Board of Directors. This organization, which helps at-risk and homeless children, valued his leadership as he inspired the Board to exceed fund raising goals through his own passion to help kids. As a result, New Pathways exceeded revenue projections, and successfully executed its strategic plan for organizational improvement and growth. His 11-year tenure continues on the New Pathways Board, where he takes a leading role in improving the lives of at-risk kids in our community.

On top of his busy career and commitment to the community, he finds time to coach his children's basketball teams and assist with events benefitting their school.
