PHOENIX (April 12, 2018) – Snell & Wilmer is committed to diversity and inclusion and demonstrates its commitment through numerous internal and external activities and initiatives. By recognizing the unique qualities of individuals, educating colleagues and building meaningful alliances, the firm strives to promote a diverse group of qualified professionals that reflect the communities and clients it serves. Over the past several months, the firm has engaged in a number of diversity and inclusion related initiatives, as follows:

- For the second consecutive year, Snell & Wilmer received a perfect score of 100 percent on the Human Rights Campaign Foundation's 2018 Corporate Equality Index, a national benchmarking survey and report on corporate policies and practices related to LGBTQ workplace equality. The Human Rights Campaign Foundation is the educational arm of the Human Rights Campaign, America's largest civil rights organization working to achieve equality for the LGBTQ community.
- The firm sponsored the Lambda Legal in Arizona fundraiser that took place on April 12, 2018. Phoenix partner Cory L. Braddock was a featured speaker at the event.
- On April 8, 2018 attorneys from Snell & Wilmer partnered with Arizona Public Service Company to march in the annual Phoenix Pride Parade.
- The firm was a sponsor of the State Bar of Arizona's annual Diversity & Inclusion Conference on March 22 and March 23, 2018. At the Diversity & Inclusion Conference, Arizona's legal community (including members of the judiciary and leading experts from the field) gathered to discuss matters relevant to diversity and inclusion in the legal profession. For this cycle, the Committee is highlighting a landmark court case focusing on the rights, liberties and freedoms related to each such group or culture. For example, on March 23, 2018, during National Women's History Month, the Committee highlighted the United States Supreme Court's decision in *United Auto Workers v. Johnson Controls.* In this case, the Court held that Title VII of the Civil Rights Act of 1964 forbids employers from adopting fetal-protection policies preventing fertile women from working in jobs that would expose them to lead or other toxins that might harm a fetus. The case represents the Court's shift in thinking of women as autonomous members of the workforce, and not only as mothers or potential mothers.
- Phoenix partner Marian Zapata-Rossa was honored with the prestigious 2018 "HNBA Top Layers Under 40" award at the 2018 Hispanic National Bar Association's Corporate Counsel Conference on March 16, 2018. This national award honors accomplished lawyers who have demonstrated professional excellence, integrity, leadership, commitment to the Hispanic community, and dedication to improving the legal profession. Zapata-Rossa was one of 32 award recipients.

- The firm was a sponsor for Xico Inc.'s 30th Annual Dinner & Art Auction on March 9, 2018. This year's event, Arte y Cultura: It Takes Two to Tango, recognized 30 years of annual celebrations with Xico, Inc., which works to nourish a greater appreciation of the cultural and spiritual heritages of the Latino and Indigenous peoples of the Americas through the arts. - On January 29, 2018, Snell & Wilmer's Denver office hosted a roundtable discussion led by Denver partner, D. Scott Martinez, with local civil rights leaders Vanita Gupta, President and CEO; and Ellen Buchman, Executive Vice President of The Leadership Conference on Civil and Human Rights.
