The members assist the Commission with its fact-finding, investigative, and information dissemination functions, according to its website. The Commission seeks to ensure that advisory committees are broadly diverse and represent a variety of backgrounds, skills, experiences, and perspectives. This diversity promotes vigorous debate and full exploration of the issues. All appointments are made in a non-discriminatory manner.
